

# NAVIGATOR AMAZING PHOTO COMPETITION OFFICIAL RULES

## THE NAVIGATOR COMPANY

NO PAYMENT, ENTRY FEE OR PURCHASE REQUIRED. OPEN TO ALL INDIVIDUALS ABOVE +18 YEARS OLD, CURRENTLY RESIDING IN ESTONIA, LATVIA OR LITHUANIA.

**1. CONTEST PERIOD:** The Navigator Amazing Photo Competition (the "Contest") begins at 12:00 AM (ET) on September 1st, 2018 and ends at 11:59 PM (ET) on December 13th, 2018 (the "Contest Period").

**2. ELIGIBILITY:** Participation open only to persons who are legal residents of Estonia, Latvia or Lithuania and who are at least eighteen (18) years old when they enter the Contest. Sponsor reserves the right to disqualify any entry, for whatever reason, including, but not limited to, a perceived or actual conflict of interest. All federal and local laws and regulations apply.

**3. RULES:** In order to win one of the two (2) prizes, participants will be requested to submit a photo to the Contest's website, in accordance to a monthly theme selected by the Sponsor. Users may follow the Contest's Social Media networks, and/or website for additional information on this theme.

**4. HOW TO ENTER:** To enter the Contest, participants may submit their photos to the Contest's webpage at [photocontest.navigator-paper.com](http://photocontest.navigator-paper.com) along with a title, and a text containing no more than 500 characters describing the picture, and the story behind it, in English. The following conditions must be met in order for the participation to be approved:

- The Photo must be in landscape mode
- Formats: jpg; jpeg; png
- Photo with maximum of 1,5MB
- Story shouldn't have more than 500 characters

There is NO limit of entries per person. Incomplete, duplicate, mechanically reproduced or automated entries are not permitted and will be deemed void. NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

**5. DRAWING:** The Prize Winners will be chosen by an elected Jury at the beginning of the next month. Prize Winners will be notified by telephone and/or e-mail within one (1) week of being selected. In order to be confirmed as a Prize Winner, the potential Prize Winners may be required to provide additional information to confirm identity and eligibility and may be required to complete and sign an Affidavit of Eligibility, a Liability Release and, where legal, a Publicity Release, and any other documentation that Sponsor may require. The prize will be forfeited and an alternate winner will be selected by the jury from the remaining eligible entries and confirmed in accordance with these Official Rules: (i) if a potential Prize Winner does not timely provide the requisite information or return the requisite documents, or cannot be reached within five (5) days from initial notification attempt; (ii) if prize notification is returned as non-deliverable; and/or (iii) in the event of non-compliance with any of the requirements of these Official Rules.

**6. PRIZES:** Two (2) Contest winners will each receive a 'GoPro – Hero6' with an approximate retail value ("ARV") of 450€. Total ARV of all prizes: €900. Winners shall be responsible for all applicable federal, state and local taxes including but not limited to any sales and income taxes. Prizes may not be substituted, transferred or redeemed for cash, except by Sponsor, who reserves the right to substitute a similar prize of comparable or greater value in its sole discretion.

**7. WINNERS:** Winners will be elected based on a Jury's decision. The criteria for this decision will take into account factors including, but not limited to, picture originality, scenery, context and others. Social Media Likes/Reactions do not, under any circumstance, affect the decision held by the Jury.

**8. DATA PRIVACY:** The collected data - name, photo and email - are required for participating in the present contest and will not be shared to third parties. The Navigator Company may use this data for future communications concerning this competition or information about its products and services.

**9. GENERAL CONDITIONS:** Contest participants agree to be bound by the terms of these Official Rules and decisions of Sponsor which are final and binding on all matters relating to this Contest.
